### Dear Members

In 2009 two reports were released that if adopted will bring significant change to service delivery in the next few years. The National Health and Hospital Reform Commission Report<sup>1</sup> and Building a 21st Century Primary Health Care System: A Draft of Australia's First National Primary Health Care Strategy<sup>2</sup> were released in 2009. What does this proposed reform agenda mean for the ACCYPN?

In 2010 there will be opportunities at a state level and national level to influence the discussion and outcomes of the reform process. Some of the proposed changes may include the need for practice changes or expanded nursing roles. I think we need to embrace these opportunities as a College and work to advance practice in the area of Children and Young People's Health. We also need to advocate for children and young people's health care to positively influence the process or to speak out if we consider the reform process to be detrimental to children and young people's health care.

It is important that members are endorsed by the Board to represent the College on matters that relate to our mission and objects.

The final WA Chapter event for 2009 was a clinical supper and certificate presentation in November. Dr Colleen Fisher from the University of WA presented her research regarding the *"Nature and context of family and domestic violence in 5 African communities from a refugee background in Perth"*. The research was conducted using a Participatory Action research. The findings were sobering and thought provoking. The community has embraced the concept and there is great buy into move forward to address the issues.

During the evening, the Scholarship presentations were also made, congratulations must go to the worthy recipients of the awards. Two scholarships are supported by the Dorothy Clarke Fund managed by the WA Chapter; the Lady Court Scholarship which is co-funded by Princess Margaret Hospital for Children and the Professional Development Scholarship. Sadly, Lady Court passed away in May this year.

**The 2009 Lady Court Scholarship** was awarded to two recipients: **Sally Wilson** to assist with the cost of data retrieval for her PhD studies looking at Nurse sensitive indicators for paediatric care, and **Maryanne Pestell** to complete her Master of Leadership and Management studies, which she puts to good use in the development of Paediatric Ambulatory care services in WA.

**The Professional Development Scholarship** was awarded to three recipients: **Leonora MacTavish** to assist with registration for the 19th Annual Mental Health Conference conducted in Perth this year, **Georgia Henman** to assist with expenses to attend the Australian Association for Infant Mental Health and The Australian Marce Society Conference titled *"The Infant, the Family and the Modern World"* held in Melbourne last month, and **Katie Anderson** to contribute to course fees for the final unit for her PGDip Child and Adolescent Health, Curtin University.

Due to her patronage the College was invited to attend a reception in honour of the organisations that both the Governor General and her husband, Mr Michael Bryce are the patron of. The afternoon reception was held on Friday the 2<sup>nd</sup> of

October at Government House in Canberra. The ACCYPN Board felt that this was an excellent opportunity to meet the Governor General and thank her for her patronage of the College. Board Director Jacquie Burton attended on behalf of the College. She had the opportunity to meet with the Governor General and thank her for her patronage.

The Governor General and Mr Bryce

are patrons to over 270 different organisations. Approximately 100 of these organisations were represented at this reception. The organisations varied considerably and included medical and children's charities as well as music, arts, sporting and military organisations. There was an eclectic mix of people leading to very interesting conversations in the room during the reception.

## Safeguarding Children – Core Curriculum for Nursing and Midwifery Students

The Centre for Midwifery, Child and Family Health, Faculty of Nursing, Midwifery and Health at UTS is currently undertaking a consultancy for the Australian Centre for Child Protection. The *Nurturing and Protecting Children: Nursing and Midwifery Curriculum Standards Project* has been undertaken by a national taskforce to help develop and promote recommended curriculum standards for Australian pre-registration and postgraduate programs in nursing and midwifery in relation to child abuse and neglect. ACCYHN was invited to make representation on this taskforce and one of its members, Dr Jennifer Fraser represented ACCYPN in this project.

A comprehensive review undertaken by the project team found that: child protection is increasingly being conceived of, both in Australia and internationally, as something including but greater than protection from harm and encompassing the aim of promoting the fulfilment of the child's potential. This approach depends greatly on the ability of all health professionals but particularly those involved in primary health care (community nurses, midwives and other health professionals in community settings such as general practitioners and dentists) having

an understanding, willingness and ability to identify child abuse, to recognise vulnerable families and individuals and to intervene as and when appropriate.

Nurses and midwives working in either acute or primary care settings need to be prepared for recognising and responding to child abuse and neglect. Nurses working in acute areas like Accident and Emergency and Paediatrics, where they may be the first point of contact for children and families, together with nurses and midwives in community care settings or settings where they provide continuity of care, are more likely to be in situations where they need to recognise the signs or risk factors of child abuse and neglect and be able to intervene appropriately. For nurses, these continuity of care roles may include: child and family health nurses; school nurses; nurses involved in caring for families with mental health issues; nurses involved in caring for families with drug and alcohol issues.

***The following benchmarks for inclusion of content in curricula are being considered by the project team<sup>1</sup>.***

1. Nationally-consistent core values, learning outcomes, and principles for learning and teaching content on nurturing and protecting children are adopted for curricula

accreditation standards<sup>1</sup>

2. Content on nurturing and protecting children is explicitly linked, across curricula, to content on health and wellbeing across the lifespan
3. Nursing and midwifery graduates demonstrate knowledge of and skills in child protection suitable for their level of practice
4. Support structures are available and accessible for the use of nursing and midwifery students, nurses, and midwives who have experienced abuse and neglect, or have been affected by issues of child abuse and neglect encountered in the course of their learning or their practice
5. Interdisciplinary approaches to teaching and learning content on nurturing and protecting children are adopted for curricula
6. Regular evaluation of content on nurturing and protecting children takes place and involves academic staff with experience in child protection and family health, and representatives from child protection agencies.
